## Is it our role?

- Jane Adams: Social worker and winner of Nobel Peace Prize 1931: cofounder of Hull House Settlement Home in Chicago for new migrants
- Major concepts underlying the development of occupational therapy: social, critical and community discipline.
- Jane Addams supported Eleanor Clarke Slagle in candidacy for president of National Society for the Promotion of Occupational Therapy
- Pushed profession to a social and critical focus: Over years was lost to mechanistic and reductionist paradigm
- Attention for social in OT as therefore not emerging and new, but reemerging and returning to the roots of the profession.
- OT has always been social and always been political

# Human Displacement in European Context

- 71.4 million people suffering from displacement end of 2017 (UNHCR, 2018)
- Fleeing national and international conflict, persecution, food insecurity, environmental catastrophe, climate chance and economic insecurity
- 2015-2016: 2,4 asylum applications in Europe
- Restriction in border crossings increase in trafficking and smuggling
- Burden falling on Southern European countries

Occupational disruption: situation of upheaval, adapting to new contexts and managing uncertain situations

Occupational deprivation: Restrictive environments (detention centres) and lack of access to cultural occupations

Occupational Injustice: Exclusion from participation in occupations due to larger system of government policies

## A New Me

• As an occupational therapist, you need to understand that individuals who don't verbalize goals may not be unmotivated, but instead may be in a position where they have no choice, or don't feel secure or able to set goals. We summarize this by saying: you may be asking someone what they want to do, in a system that actually encourages people to wait and do nothing.

## A New You

 The father, though home, was in no way expected to provide any kind of personal care for the mother. This would have been inappropriate. Here it was the expectation that the daughters would fulfil this caregiving role. If an occupational therapist fails to recognize this, or attempts to force individuals into other roles without an open discussion on role expectations, then this can result in negative feelings from the refugee and the refugee's family.

## **Current Practices**

- The Participatory Occupational Justice Framework (Whiteford et al., 2017): WHAT, WHY, HOW and WHERE
- Can be used to examine the role of OT with marginalized groups
- Requires OT's to 1) Develop a critical viewpoint, 2) recognize power practices and 3) focus on the environment: beyond the physical to include institutional, political and legal.



## Sarah Novak: Berlin Germany

#### Café Breakout

- Model of café based on occupation-based theories and models
- Recognized a gap in services between school and work: nothing to do
- Refugee run café, open to public but run by youth, including refugees
- Refugees work 6 months and while working receive training to help pursue future career opportunities



## Theodoris Bogas: Athens, Greece

**Promoting Occupational Justice in a Refugee Camp in Greece** 

- Solidarity Now: Programing focused on children to promote psychosocial wellbeing, education and reiliance
- Advocate for social inclusion of refugees, providing platform for voice of service users in the design of programs

### Discourse on Integration in Programs for Refugees in the Netherlands

- Researches integration programs to explore how integration is being promoted in practice, comparing government programs to those which have been started by refugees
- Aims to understand in what why the context promotes "good" citizenship and "successful" integration to refugees and what impact this has on their day-to-day life and occupations
- Community of inquiry with refugees and service providers to inform practice development

## Virve Vijanen: Finland

**Enablement Approach in Cultural Psychiatric Outpatient Clinic** 


- PhD research on the perceptions of occupation for people seeking asylum in the UK.
- Raises connections between seeking asylum and low self-worth, particularly through reduced access to occupational opportunities
- Low demand, low status occupations reduced a sense of purpose and well-being
- Waiting, Waiting Quote



 "Not enough research is done in this field altogether. There is some done in the community-based treatments or therapy, but assessment, evaluations and intervention and the ways we need to see the human uniqueness is missing, and in this case it's really uniqueness. Since we don't have the assessment methods - we miss information - something more solid to the reality of the immigrant and refugee."



• "For example, I found that occupations that are allowed, obligatory, forbidden or gender-based are important to understand. This is important as part of your activity analysis. You need to understand the gender rules in other cultures which shape these activities and occupations that are meaningful, which also questions our occupational therapy point of view of what a "normal" ADL is. We need to redefine these because they are not the same all over the world."



 "It is difficult for professional organizations; they want to write position papers but there is a lot of discussion around it, so it takes a long time. Other professions have had their papers out quicker and now occupational therapy is missing from the discussions. They are in a difficult political situation in our country, so the professional association wants to play it safe."



• "Students need to understand the culture first: interview, discuss, question which we can use to understand the background of people and only then can you start to evaluate what it means now in the reality they are in now and what this means for the matching of the occupational roles here and there."


